New Business

- 6. District election is to be held on December 12. Ron is up for another 5 year term.
- 7. The request for Yeidy to take the 6-wheeler to an event in Jamestown was cleared by the insurance company email was sent on this previously.
- 8. Paul reported that Yeidy and her husband Austin gave a short presentation to the department after the November meeting. It summarized the information about current drugs to watch for.
- 9. Chief's report:
 - Training has been well attended this month. The first one was on CO detection and info was passed out to all the participants telling about things to watch for. A discussionf about CO meters pointed out that there are two meters currently – on Otto1 and Otto7. Motion to buy two meters for Otto8 and personnel: made by Ron, seconded by Kim, approved. Paul will also look into getting the 4 gas meter repaired.
 - There was a training on chimney fires.
 - DEC grant was submitted. It suggests tools to be bought shovels, rakes, pole saw, lights. The electical tools would be compatible with current tools.
 - Otto5 is leaking a small amout of water, but it is not clear what the problem is.
